 - A. A clear and conspicuous disclosure is first made, in writing, to the consumer that a consumer report may be obtained for employment purposes and that the disclosure is a document that consists solely of the disclosure;
 - B. The consumer has authorized, in writing, the procurement of the report; and
 - C. Information contained in the Consumer Report for Employment Purposes will not be used in violation of any applicable federal or state equal employment opportunity law or regulation.
5. Subscriber further certifies that, before taking adverse action based in whole or in part on information contained in the Consumer Report for Employment Purposes, it will provide the consumer:
 - A. A copy of the Consumer Report for Employment Purposes; and
 - B. A copy of the consumer's rights, in the format approved by the FTC, which shall be provided by Safenet Corporation powered by FastraxSelect.
6. Subscriber agrees that it shall use Consumer Reports for Employment Purposes for one-time use only, to hold the report in strict confidence and not to disclose it to any third party not involved in the current employment decision.
7. Subscriber will maintain copies of all written authorizations for a minimum of three (5) years from the date of inquiry.
8. With just cause such as delinquency, violation of the terms of this agreement or negligence in fulfilling a legal requirement, SafeNet Corporation powered by FastraxSelect may, upon its election, discontinue serving the Subscriber and cancel this Agreement immediately.
